Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

Section 5 of the COVID–19 Hate Crimes Act, entitled the "JABARA-HEYER NO HATE ACT" authorizes the Attorney General to make grants to states to create state-run hate crime reporting hotlines. The purpose of this solicitation is two-fold: OVC seeks (1) applications to establish state-run hate crime reporting hotlines designed to assist victims who might otherwise be reluctant to report hate crimes; and (2) applications to enhance the quality of services and referrals for hotline users by providing specialized training and technical assistance (TTA) to all award recipients under this program. OVC encourages state governments to form partnerships with community-based organizations, culturally specific entities, and other partners with access to the populations intended to benefit from the state hate crime hotline to fulfill the goals of this solicitation. Therefore, OVC welcomes applications under which two or more entities would carry out the federal award; however, only the state agency may be the applicant and must be the entity with primary responsibility for administering the funding and managing the entire project.

Statutory Authority

34 U.S.C. § 30507(e)

Specific Information

Purpose Area 1 - State-Run Hate Crime Reporting Hotlines

The Jabara-Heyer NO HATE Act State-Run Hate Crime Reporting Hotlines program authorizes grants to states to create state-run hate crime reporting hotlines. The state applicant is required by law and under this solicitation to ensure the following.

- The hotline will direct victims of hate crime to—
 - local support services, and
 - law enforcement, if appropriate.
- Any personally identifiable information that an individual provides to an agency of the state through the hotlines is not directly or indirectly disclosed without the consent of the individual. to—
 - any other agency of the state,
 - any other state,
 - the Federal Government, or
 - any other person or entity.
- The staff members who operate the hotline are trained to be knowledgeable

about—

- applicable federal, state, and local hate crime laws;
- local law enforcement resources;
- o applicable local support services; and
- trauma-informed responses and working with victims.
- The hotline is accessible to—
 - individuals with limited English proficiency, and
 - o individuals with disabilities.

The hotlines funded under this program are intended to support victims who might be reluctant to report hate crimes to law enforcement. Project designs should address how these victims will be assisted. Applicants must demonstrate their plans for collaboration with stakeholders (potentially including other hotlines) to complete a community resource map, which identifies the needs of the community and the resources available to address those needs through a hate crime reporting hotline; policies to govern the operation of the hotline; and outreach/marketing plans. Detailed language and accessibility plans are pivotal.

Purpose Area 2 - Training and Technical Assistance (TTA)

Under this category, the applicant will develop and deliver training and technical assistance designed to assist OVC grantees and other stakeholders under this program to ensure successful implementation of state-run hate crimes hotlines, by—

- providing TTA regarding hotlines, models, or implementation strategies;
- providing TTA on hate crimes, hate incidences, reporting options, etc.:
- assisting grantees in developing resource materials and awareness information on hate crimes and related topics;
- offering peer-to-peer learning opportunities; and
- conducting activities to effectively increase awareness and use of state-run hate crime reporting hotlines.

Applicants must demonstrate experience and expertise in victimization and in delivering TTA. Applications representing partnerships among two or more qualified organizations to meet these requirements are welcomed.

Under both categories, OVC will give preference to applicants that document support for the proposed project (with Memoranda of Understanding (MOU) or Letters of Support).

Goals, Objectives, and Deliverables

Goals

The primary goal is for state agencies to establish and operate state-run hate crime reporting hotlines to facilitate significantly increased reporting of hate crimes data, and to ensure that victims are connected to available support services and informed about their options for reporting to law enforcement. In addition, OVC is seeking to support award recipients under this program by providing training and technical assistance to them

through a dedicated provider.

Objectives

Under Purpose Area 1, successful applicants will strive to achieve the goals of this program through the following objectives, as applicable:

- Collaborate with existing national or state-run hotlines for peer-to-peer learning on the successful implementation of state-run hotlines.
- Collaborate with stakeholders including victim service providers, survivors, persons with lived experiences, community-based organizations, culturally specific organizations, faith-based organizations, and other allies to complete a community resource map to identify the needs of the community and the resources available to address those needs through a hate crime reporting hotline.

Under Purpose Area 2, the technical assistance provider will support the grantees' activities related to the attainment of the above objectives.

An applicant should address all the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables and Timeline web-based form.

Deliverables

Under Purpose Area 1, applicants should address the following deliverables.

- 1. A strategic plan that should include, but is not limited to, the following:
 - a. Criteria to best determine strategies and effective collaborative models for developing effective state-run hate crime reporting hotlines.
 - b. An assessment plan to measure project effectiveness in achieving the identified outcomes.
 - c. An outreach/marketing plan that outlines the ways the grantee will raise awareness of the state-run hotline, particularly to reach communities and individuals most likely to be targeted by hate crimes. The plan must include a language access strategy and be approved by DOJ prior to the release of the state-run hotlines.
 - d. A summary report of all strategic planning committee meetings and strategic planning sessions with community stakeholders.
- Policies and procedures that will govern the operation of the hotline, including
 policies that address the privacy and confidentiality of hotline callers; referrals to
 trauma-informed victim services; law enforcement reporting procedures; staff
 training; and accommodations for persons with disabilities or limited English
 proficiency.
- 3. A language access plan to include interpretive services available to callers, translation of outreach materials, and stakeholder engagement.
- 4. A final implementation plan based on the strategic planning process.
- 5. A comprehensive assessment of the project, which should include but is not limited to, an analysis of outputs.
- 6. A detailed final report that includes the following:
 - a. A description of the project goals, challenges, successes, and strategies.

- b. An implementation plan and any needs assessments, surveys, or other assessment devices completed during the project.
- c. A discussion of the comprehensive assessment of the project, including output analysis.
- 7. Other deliverables as identified by DOJ/OVC.

Under Purpose Area 2, the TTA provider will develop and deliver training and technical assistance designed to assist hotline grantees in implementing their project successfully, including, but not limited to, the following:

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
