Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Office for Victims of Crime</u> (OVC) seeks applications for an organization to financially, programmatically, and administratively support up to 100 subgrants to requesting organizations nationwide that propose to print and disseminate the OVC-published <u>Child Victims and Witnesses Support Materials</u>, and to conduct active national outreach and awareness about the availability and use of these materials. This program furthers the DOJ's mission by enhancing the field's response to young victims of crime and their caregivers and families.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Submission Information

Registration and renewal can take up to 10 business days to complete.

<u>Submission:</u> Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OVC seeks to enable an organization to provide financial, programmatic, and administrative support for up to 100 subgrants of up to \$10,000 each to organizations nationwide that propose to print and disseminate the OVC-published *Child Victims and Witnesses Support Materials*.

Statutory Authority

This project is authorized by 34 U.S.C. § 20103(c)(1)(A).

Specific Information

Between 2020 and 2022, OVC published *Child Victims and Witnesses Support Materials*, a series of graphic novels and comic books, which are available to download and print from the OVC website. To further assist national dissemination and increase access to these materials, OVC will select an applicant to administer subawards to organizations interested in printing professional copies of the materials. The successful applicant will develop a strategy and implement a plan to advertise the subrecipient opportunity; offer a vehicle by which interested parties can apply; vet the applicants to ensure the applicant organizations serve or interact with child/youth victims and witnesses; review the applications to ensure they are in scope, will reach the intended audience, and that the subgrant amount requested is reasonable and justifiable; and submit recommended subawards to OVC for final approval. All subgrantees must certify prior to receiving the award that the materials will be provided to individuals and communities at no cost. The successful applicant will monitor the subgrants to ensure the funds are expended as intended. The successful applicant will also conduct outreach and awareness at relevant venues and events to increase community awareness of these resources.

Goals, Objectives, and Deliverables

The goal of this project is to increase access and availability of the OVC-published *Child Victims and Witnesses Support Materials*, fulfilling their intended purpose of supporting young victims and witnesses that interact with the justice system.

Objectives

An applicant should address all the objectives listed below in the Goals, Objectives,

- Financially, programmatically, and administratively award, support, and monitor up to 100 subgrants of up to \$10,000 each to organizations nationwide who propose to print and disseminate the OVC published *Child Victims and Witnesses Support Materials*.
- Conduct outreach and awareness on (a) the materials themselves and (b) the opportunity for subawards for printing and dissemination available through the project.
- 3. Collect data on the types of organizations requesting the materials and the specific versions of the materials that are being printed and used.

Deliverables

Project activities and deliverables include the following:

- Develop and administer an outreach and awareness plan.
- Develop and administer application and review processes for subawards.
- Develop and administer a monitoring process for subawards, including receiving, reviewing, and summarizing after-action reports, including documentation and verification of expenses.
- Advertise and publicize the application opportunity through OVC and other public venues
- Issue funds to selected subrecipients in a timely fashion.
- Answer questions and provide support to selected subrecipients as necessary.
- Prepare a final report for OVC on the overall project, including data obtained about materials requested and feedback obtained while conducting outreach and awareness.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project—including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known)—must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the OJP Grant Application Resource Guide for an example of a proposal abstract. If priority consideration is being requested, please indicate the priority areas A and/or B selected.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 20 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, OVC may consider such noncompliance in peer review and in final award decision. Tables, charts, and graphs

included in the proposal narrative can be created in a legible font smaller than 12 point and will count toward the page limit.

The Proposal Narrative must include the following sections:

a. Description of the Issue

The Description of the Issue must describe the need for the project, using data if available. The applicant should describe the current use of the OVC-published *Child Victims and Witnesses Support Materials*, as well as obstacles to their use and dissemination to stakeholders across the country supporting young victims and witnesses that interact with the justice system.

b. Project Design and Implementation

The Project Design and Implementation plan must describe the project strategy and discuss how the strategy will address the problems identified and support the goals and objectives. The applicant's strategy or design must include a description of project phases, tasks, activities, and staff responsibilities, and clear descriptions of interim deliverables and final products. It must include a time-task plan that clearly identifies objectives, major activities, and products for the duration of the project period. The applicant must also describe the strategy, tasks, and time-task plan for developing the services and products.

As a separate attachment, the time-task plan is not subject to the page limitations of the proposal narrative. This plan must include the designation of organization responsibility and a schedule for the completion of the activities and the submission of finished products. In preparing the time-task plan, the applicants should make certain that all project activities will occur within the proposed project period. The plan also must provide for the submission of financial and progress reports.

If the applicant is seeking priority consideration for **Priority A**, it should address in this section how the proposed project will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

c. Capabilities and Competencies

This section must demonstrate the applicant's (and if applicable, their partners') institutional experience and expertise to effectively implement the requirements of this solicitation. The applicant must include a clear description of their management structure and a description of the current and proposed professional staff members' unique qualifications that will enable them to fulfill their grant responsibilities.

The applicant must describe how the program will be managed and include an organizational chart or information describing the roles and responsibilities of key organization and functional components and personnel. The applicant must also include a list of personnel responsible for managing and implementing the major stages of the project.

If the applicant is seeking priority consideration under **Priority B**, it should describe within this section how being a culturally specific organization (or funding a culturally specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s), should also specify which populations are intended or expected to be served or have their needs addressed under the proposed project(s), and should include the website address (if applicable) and formal or informal mission statement or principles of the culturally specific organization.

- d. Plan for Collecting the Data Required for this Solicitation's Performance Measures
 - 1. A plan for collecting all of the performance measures data required by this solicitation.
 - 2. A description of the qualifications of the key staff who will be responsible for collecting data and reporting performance measures in JustGrants.

Note: An applicant is **not** required to submit performance data with the application. Rather, performance measure information is included as a notification that award recipients will be required to submit performance data as part of each award's reporting requirements. Some measures are presented as examples, while others are the exact measures that every recipient will be expected to address.

OJP will require each award recipient to submit regular performance data that show the completed work's results.
