The following pages detail the supplemental performance measures for the Office for Victims of Crime's (OVC) Emergency and Transitional Pet Shelter and Housing Assistance grant program.

GOAL AND OBJECTIVES

The primary goal of this project is to enable domestic violence shelters to become pet-friendly so that victims of domestic violence and their pets may seek safe shelter together. A large majority of domestic violence shelters do not allow pets, and the reasons for this may vary. Therefore, this program will provide funding for shelters that want to be able to house domestic violence victims and their pets.

This program supports projects that provide the following:

- 1. Emergency and transitional shelter and housing assistance for domestic violence victims with companion animals. This includes modifications to existing structures to provide for housing animals and the operating expenses of newly developed or existing emergency and transitional companion animal shelters for companion animals.
- Short-term shelter and housing assistance for domestic violence victims with companion animals; including expenses incurred for the temporary shelter, housing, boarding, or fostering of their companion animals and other incidental expenses that secure the safety of such animals.
- Support services designed to enable persons who are fleeing a situation of domestic violence to locate and secure safe housing with their companion animal; safe accommodations for the victim's companion animal; or companion animal-related services, such as transportation, care services, and other assistance.
- 4. Training resources for relevant stakeholders on the link between domestic violence and the abuse and neglect of companion animals; the needs of victims of domestic violence; and best practices for providing support, services, and referrals.

STRUCTURE OF THE QUESTIONNAIRE

This questionnaire includes supplemental performance measures that are asked of Emergency and Transitional Pet Shelter and Housing Assistance grantees during each semiannual reporting period.


