NARRATIVE QUESTIONS

1. Please explain any significant change in the number of applications received during the reporting period.

The variance between FY 18-19 and FY 19-20 is 378. There was a total of 378 less applications received in FY 19-20 than FY 18-19. The pandemic affected every aspect of existence. The largest variance occurred with non- homicide claims.

2. The average length of time to process an application for claim eligibility for compensation

Count days from time of receipt of application to decision. 67

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. 185.30 days. The Commission s specialists who process claims have been reduced by nearly 50%. Once the Commission had 11 specialists who processed claims. Currently, there are 6. With a reduction in revenue, the Commission has been unable to replace specialists who retire or leave to take other positions. The application is received into the office, date stamped and assigned to a specialist by jurisdiction(county). the victim or claimant (V/C) is sent an initial letter informing them that their application has been received and the letter sets out specific information that is needed to continue processing the application. Additional requests may be made of the V/C, service providers, victim service officers, law enforcement, etc. A summary of the incident is written based upon information gathered during the review process. All the information is received and reviewed, then the specialist makes an eligibility recommendation. The claim is completed by the specialist, it is team reviewed by the claims managers, the attorney, and executive director. Claims for compensation over two-thousands dollars are forwarded to the Commissioners for the decision. They complete the review of the claims and send the packet back. The administrative assistant documents all claims that were agreed upon for consent docket and those that were not agreed upon or need further discussion are put on a non-consent docket for the monthly Commission Meeting(second Thursday of each month). The executive director makes decisions on all claims under two-thousand dollars and under. For all claims that are approved, the payment are imported from the claims system to the accounting system. Once the accounting system has processed that information and cut checks, the checks information is exported from the accounting system to the claims system to print letters. The checks are signed by the director and other individual or two other individuals in the executive director's absence and sent to the victims, claimant, payee or service provider.

3. Does your state have a victim satisfaction survey?

No

Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

Some victims and claimants appear to be transient and rarely update contact information. Therefore, it is very difficult to follow-up with them or get additional required information. Often claims are not approved or the approval/decision date is protracted because the victim or claimant does not respond to requests at the address or telephone numbers they provided. The COVID pandemic has had a deleterious affect on virtually every area of daily life. Many offenders who were ordered to pay fines, fees, and restitution, found themselves like most of the world in new territory. They were unable to make their usual if any payment to the courts to send to our office. It also appears that some judges who are reticent to require offenders to pay assessment fees have negatively impacted the Commission. Each year, the amount of funds from the courts decreases, which means less funds for victims and other programmatic areas. Other criminal justice reforms involve laws dealing with sentencing, and guidelines for felony and misdemeanor charges which impact fees. The state s general fund has been unable to fund state police at acceptable levels in the past. The state has recently begun to hire more state police which is likely to increase the amount received from each speeding ticket. The number of officers has not risen to the acceptable level in the state. Therefore, less funds are going to the courts and thus to victims. Since at one time, medical payments accounted for the largest category of payments, the Commission has been forced to reduce its medical payout from 100% to 50% and finally to 30%. These reductions are necessary to allow the Commission to continue to pay victims and remain financially sound.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

The Commission enjoys a good professional relationship with victim service officers who work for the federal government. We complete the memorandum of understanding for reports needed from the Federal Bureau of investigation. They refer victims, and we share information on claims to assist victims.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

The Commission continues to provide hands-on assistance to homicide survivors who come into the office. A special presentation was made to the Association of Funeral Directors in the state of Alabama to assist them in helping our victims.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

The Commission used its five percent administrative funds to cover administrative costs and to provide additional services to victims.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

On July 9, 2020, The Commission reduced its total payout from \$20,000 to \$15,000. Several categories such as emergency awards, moving, lost wages, total weeks of lost wages, funeral costs, property, travel, replacement services, alarm system, security, and exigent circumstances were reduced. These reductions were necessary because of a reduction of revenue from fines, fees, and restitution. Revenue was already on a decline. However, the pandemic and concomitant loss of employment and business closures led to an even greater reduction of revenue.

9. Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

The Commission has a positive relationship with prosecutors, law enforcements, the U.S. Attorney's Office, and VOCA Assistance Coordinator. The Commission also has a good working relationship with the Attorney General Office. The Commission staff has memberships on and attends human trafficking and Elder Abuse committees to affect change to help vulnerable populations.

10. Please explain any public outreach efforts to improve awareness of your program.

Presentations are made to various organizations, committees, churches. law enforcement academies, funeral directors, child advocacy centers, hospitals and social services agencies to improve their awareness of our program.
