As a result of the COVID-19 pandemic, the Victims of Crime Compensation Program (VOCP) has experienced a decrease in the number of VOCP applications received between July 1, 2020 - September 30, 2020 (798 VOCP applications) compared to July 1, 2019 – September 30, 2020 (1,000 applications).

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Once an application is received, a request for a police report is submitted within 24-48 hours of receipt of application. Upon receipt of police reports, both the application and PR are reviewed, a decision is made and decision letters are mailed out within 2 days of decision. If the police report is included with the application, both documents are reviewed and a decision is made within 24-42 hours of receipt.

#### 4. Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

In March 2020, our Victims of Crime Compensation program (VOCP) office was closed due to the COVID-19 pandemic. As a result of the closure, our VOCP operations were taken completely online, with the application processing being handled electronically through electronic submission of the VOCP applications submitted over email. As the VOCP staff have resumed a partially remote, partially in office schedule, the program has resumed normal functioning in terms of application processing but has noted an increase in requests to extend relocation timeframes for applicants to acquire a new residence, even after being approved for relocation through VOCP.

The VOCP staff works to efficiently process VOCP applications and ensure victims of crime receive adequate compensation and benefits for resources for which they qualify.

# 6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

The VOCP office began utilizing additional tracking spreadsheets to ensure administrative staff were requesting policy reports and police report verifications in a timely manner and conducting adequate follow-up requests if needed. The additional tracking sheets were also utilized to ensure that decision letters for applicants to VOCP were also issued in a timely manner.

#### 7. Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

VOCA Administrative funds are utilized to pay for personnel and operating expenses needed to ensure the Victims of Crime Compensation program is adequately staffed to meet the needs of the individuals that submit applications to the program.

# 8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

There were no law, initiative or policy changes during the reporting period.

Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

Since the Victims of Crime Compensation Program (VOCP) was moved to the Division of Child and Family Services (DCFS), effective July 1, 2020, the program has been able to more adequately communicate with the Grants Management Unity within DCFS, that administers other victim service funding such as the VOCA Assistance grant. Within DCFS, more subrecipient agencies funded under other victim service grants have received additional technical assistance and encouragement to promote and conduct outreach to further publicize the benefits of the VOCP program.

Due to the COVID-19 pandemic, planned outreach events have been cancelled; however, the Division of Child and Family Services (DCFS) has been more proactive in publicizing the VOCP to non-profit and other government agencies at the county levels, about the VOCP program to further its outreach to more people across the State of Nevada.
